- Maintaining accredited certification of our management systems in accordance with ISO 9001, ISO 14001 and ISO 45001.
- Maintaining an integrated documented management system that provides the necessary controls in support of the above recognised management system standards.
- Providing the necessary resources to meet the requirements and expectations of our customers along with meeting our obligations regarding health and safety of all interested parties and to reduce our impact on the environment.
- Periodic review of this policy to ensure its continued relevance
